## Decree of the President of the Republic no. 31/2010 of 20 August 2010

The 2006 crisis and subsequent instability were an expression of the political culture of violence the national community had been subjected to throughout our recent history and do not represent the founding values of our society and State.

Our way of being is also characterised by noble qualities, reflective of the vast majority of our national community.

One of such noble qualities is the capacity to pardon. Another one is the will to work with the hope of building a better future. The capacity to overcome grievances and resentments has been repeatedly proven by the people and by our tradition throughout the aggrieved history of the Nation.

Pardoning is an expression of love toward others and a manifestation of faith in our peer's capacity to improve and repent, and these are civilisational values on which our national community is based.

Thus, on the occasion of Falintil-FDTL's anniversary, on the date that we celebrate the sacrifice of Timorese men and women who took up arms in order to give us peace and freedom, on behalf of the People of Timor-Leste, our State makes a gift of reconciliation with a view to definitively burying the sadness and pain caused by the 2006 crisis to our country.

To that end, pursuant to article 85 (i) of the Constitution of the Democratic Republic of Timor-Leste, the President of the Republic, after hearing the Government, enacts the following:
