# Presidential Decree no. 60/2010 of 23 December

For humanitarian reasons, and with the objective of providing individuals convicted for committing minor offensive potential crimes with the means to enable them to have an opportunity to re-socialise once they are reinserted in society;

Considering also that family reunion, particularly the experience of living in society, is one of the most effective means for achieving re-socialisation;

In the framework of the efforts to provide more dignified and humane conditions for the social reinsertion of individuals sentenced to penalties of imprisonment not exceeding 3 (three) years, excluding those individuals convicted for committing consummated crimes against life and sexual freedom, and in order to ensure reintegration of convicted individuals into their families, the latter being the true foundation of a democratic, just and citizen society;

The President of the Democratic Republic of Timor-Leste, in the exercise of his exclusive competence, after hearing the Government, and pursuant to article 85, subparagraph i), of the Constitution, enacts the following:

# Article 1

### Total pardon

1. Total pardon is granted to individuals sentenced to a penalty of imprisonment not exceeding 3 (three) years who have served at least 1 (one) year of the penalty and have had good behaviour during such period.

2. The provisions of the preceding paragraph shall not apply to individuals sentenced for having committed consummated crimes against life or sexual freedom.

### Article 2

# Partial pardon

1. A partial pardon of 1 (one) year is granted to individuals sentenced to a penalty of imprisonment not exceeding 3 (three) years who have served at

least 10 (ten) months of the penalty and have had good behaviour during that period.

2. The provisions of the preceding paragraph shall not apply to individuals sentenced for having committed consummated crimes against life and sexual freedom.

# Article 3

1. Inmates whose names are contained in annexes I and II are hereby pardoned pursuant to articles 1 and 2 of this statute.

2. The annexes referred to in the preceding paragraph are an integral part of this statute.
