

**Correction Statement No. 01/2009**

**of 4<sup>th</sup> of November**

Decree-Law No. 27/2009 of 9<sup>th</sup> September, published in the Official Journal of the Republic., 1<sup>st</sup> Series, No. 32 of 9<sup>th</sup> of September 2009, which approves the Legal Regime covering Bailiffs and Court Secretariat Services of the Public Prosecutor's Office and Public Defender's Office included the following errata, which hereby shall be corrected:

1. In paragraph 3 of article 82 . "Entrance exams for justice employees", where it is written: "... occupy the post of 1<sup>st</sup> class justice department employees, 1<sup>st</sup> class justice employees of the Public Prosecutor's Office or 1<sup>st</sup> class justice employees of the Public Defender's Office..."

should read:

"...occupy the posts of 2<sup>nd</sup> and 3<sup>rd</sup> class justice department employees, 2<sup>nd</sup> and 3<sup>rd</sup> class justice employees of the Public Prosecutor's Office and 2<sup>nd</sup> and 3<sup>rd</sup> class justice employees of the Public Defender's Office ...".

2. In paragraph 4 of article 82 "Entrance exams for justice employees", where it is written: "...2<sup>nd</sup> class justice department employees, 2<sup>nd</sup> class justice employee of the Public Prosecutor's Office or 2<sup>nd</sup> class justice employee of the Public Defender's Office ..."

should read:

"... 3<sup>rd</sup> class justice department employee, 3<sup>rd</sup> class justice employee of the Public Prosecutor's Office or 3<sup>rd</sup> class justice employee of the Public Defender's Office ...".
