First alteration to Law no. 10/2007 of the 31st of December, which approved the General State Budget for 2008

The present law is intended to complement and update the General State Budget (GSB) for 2008.

The GSB Amendment encompasses an update of the receipts and expenses of the State of East Timor.

Annex I establishes the estimated total State receipts from January to December 2008 deriving from all sources: Petroleum, non-petroleum, development partner fees, receipts from autonomous agencies and other non-fiscal receipts. The estimated total income from all theses sources is now US \$ 2,025.6 million.

Annex II alters the budget estimates for each State Body, broken down in the following fashion:

- 1. \$ 58.884 million for Pay and Salaries;
- 2. \$ 447.409 million for Goods and Services;
- 3. \$ 39.249 million for Minor Capital;
- 4. \$ 110.553 million for Development Capital;
- 5. \$ 132.217 million for Public Transfer payments.

The total estimated budget expenditure is, therefore, \$ 788.312 million. Excluding autonomous bodies, total budgeted expenditure in the GSB is \$ 765.966 million.

The State Treasury Accounts include all the receipts and expenses arising from the self-financed "Autonomous Bodies", specifically the East Timor Electricity Company (EDTL), the Airport and Air Navigation Administration of East Timor, the Port Authority of East Timor and the Institute of Equipment Management. The receipts from these categories are included under the heading of "Receipts from Autonomous Bodies" in Annex I, with the proposed budgetary expenses set out in Annex III.

The estimated total for self-financed "Autonomous Bodies" expenses in 2008 is \$ 22.346 million (including an additional value of \$ 15.358 million transferred from the Central Government in order to subsidise expenses higher than the forecast receipts).

The estimated total for expenses in the GSB is \$ 788.3 million, with non-petroleum receipts estimated at \$ 86.5 million. The non-petroleum fiscal deficit is \$ 701.8 million.

The National Parliament decrees, under the terms of line d) of no.3 of article 95 and of no. 1 of article 145 of the Constitution of the Republic, to have the status of a law, the following:

Article 1 Alteration to the General State Budget for 2008

- 1 The General State Budget for 2008, approved by law no. 10/2007 of the 31st of December, amended by Amendment Declaration no. 1/2008 of the 16th of January, is altered, whether in relation to the tables contained in Annexes I, II and III to this law, or under the terms of the following articles.
- 2 The alteration referred to in the previous number is contained in the tables of Annexes I, II and III to the present law, which replace the tables of Annexes I, II and III of Law no. 10/2007 of the 31st of December
- 3- Articles 4 and 8 of Law no. 10/2007of the 31st of December are amended to have the following wording:

"Article 4

Under the terms and for the purposes set out in article 7 of Law no. 9/2005 of the 3rd of August, the amount of the petroleum fund transfers for 2008 will not exceed 686.8 million United States dollars.

Article 2 Addenda to the General State Budget for 2008

Articles 2-A and 9-A are added to Law no. 10/2007 of the 31^{st} of December, with the following wording:

"Article 2-A Multi-year investment programmes

- 1 The multi-year investment programmes involve large-scale projects, to be carried out over a number of budgetary years.
- 2 The spending set out for the 2008 financial years in regard to the programmes contained in Annex IV to the present law is approved, without prejudice to the total expenses set out in Annex II.

Article 9-A Economic Stabilisation Fund

The Economic Stabilisation Fund, created by decree law no. 22/2008 of the $16^{\rm th}$ of July, is administered by the Ministry of Finance."

Article 3 Entry into force

The present law comes into force on the day immediately following its publication in the Journal of the Republic.
