## RESOLUTION OF THE NATIONAL PARLIAMENT NR. 3/2009 of February 25th, 2009

# PERFORMANCE OF NR. 4 OF ARTICLE 8 OF THE LAW OF ORGANIZATION AND OPERATION OF THE PARLIAMENT ADMINISTRATION, REFERRING TO THE FOOD AND TRANPORTATION ALLOWANCE, AND ACCOMMODATION AND TELECOMMUNICATIONS ALLOWANCE.

Number 4 of Article 8 of Law of Organization and Operation of the Parliament Administration, Law nr. 15/2008, of December 24th, 2009, hereinafter referred to as LOFAP, ensures the employees of the National Parliament Services the right to transportation from and to the workplace and food allowance, besides the provision of accommodation and telecommunications allowances for the holders of management/supervision positions.

The same number of referred Article of the aforementioned law causes to be approved by resolution, submitted by the Board of Directors, as when and how such benefits are guaranteed.

Thus, the National Parliament resolves, under the provisions of Article 92 of the Constitution of the Republic and of item d) of nr. 5 of Article 8 of LOFAP, as follows:

#### **Food and Transportation Allowance**

- 1 For all intents and purposes under nr. 4, items a) and b), item d), of Article 8 of LOFAP, the Staff of the National Parliament Service, without differentiating the categories or positions:
  - a) is entitled to the supply of a daily food allowance in the amount of US\$ 3 per each workday in excess of 6 effective work hours;
  - b) is entitled to be transported from and to the workplace, by a means of transportation available at the employee's disposal according the timetable and conditions to be established by the General Secretary, without prejudice to the denomination of the holders of positions as general secretary, director and division manager and the categories of employees to be determined, by reason of the nature of their job duties, of the exclusive use of vehicles, which the National Parliament may put at their full disposal and under the provisions as such use is regulated.

## Accommodations and Movable Telecommunications Allowances for the Holders of Management and Supervision Positions

- 2 For all intents and purposes under item c) of nr. 4 of Article 8 of LOFAP, the holders of management/supervision positions of the General Secretariat are entitled to:
  - a) An accommodation allowance in the amount of US\$ 400, 250 and 150, respectively, for the general secretary, directors and division managers;
  - b) A movable telecommunications allowance in the amount of US\$ 250, 150 and 100, respectively, for the General Secretary, directors and division managers.

#### **Effectiveness**

3 - This resolution becomes effective on January 1st, 2009.
