# **DIRECTIVE NO. 2001/13**

# ON THE REMUNERATION OF THE MEMBERS OF THE GOVERNMENT AND OF THE CONSTITUENT ASSEMBLY

The Special Representative of the Secretary-General (hereinafter: Transitional Administrator),

Pursuant to the authority given to him under United National Security Council resolution 1272 (1999) of 25 October 1999, as reaffirmed in United Nations Security Council resolution 1338 (2001) of 31 January 2001,

Taking into account United Nations Transitional Administration in East Timor (UNTAET) Regulation No. 2001/2 of 16 March 2001 on the Election of a Constituent Assembly to Prepare a Constitution for an Independent and Democratic East Timor and UNTAET Regulation No. 2001/28 of 19 September 2001 on the Establishment of the Council of Ministers,

Taking into further account UNTAET Regulation No. 2001/21 of 24 July 2001 on Appropriations (No.1) 2001-2002 for the purposes of appropriating money out of the Consolidated Fund of East Timor for the services of the agencies of the civil administration of UNTAET and for related purposes,

And, taking into account UNTAET Regulation No. 2001/29 of 20 November 2001 on Supplementary Appropriations (No. 1) 2001-2002 for appropriating money from the Consolidated Fund of East Timor for salaries, wages, goods, services and capital items for the Transitional Government,

For the purpose of prescribing the remuneration of the representatives of the Constituent Assembly and of the members of the Transitional Government, and related matters,

And upon the recommendation of the Council of Ministers of 18 October 2001, made under Section 3.1 (d) of UNTAET Regulation 2001/28,

Promulgates the following:

#### Section 1 Remuneration for Representatives of the Constituent Assembly

1.1 The representatives of the Constituent Assembly shall receive the following remuneration:

1.2 The President and the Deputy-President are entitled to the use of an official car.

1.3 For purposes of Section 1.1 of the present Directive, the per diem is payable to a representative per each effective sitting day in the Constituent Assembly.

### Section 2 Remuneration for Members of the Government

2.1 The members of the Transitional Government shall receive the following remuneration:

Senior Minister	\$750	\$6,000 for support staff costs; \$30,000 travel expenses; and \$2,000 representation expenses.
Minister	\$750	\$5,500 for support staff costs; \$5,000 travel expenses; and \$1,500 representation expenses
Deputy Minister and Secretary of State	\$600	\$5,000 for support staff costs; \$3,000 travel expenses; and \$1,500 representation expenses
Inspector General	\$500	
Advisor	\$500	\$5000 for goods and services

2.2 The annual budget, as referred in Section 2.1 of the present Directive, indicates a financial year, commencing on each 1 July and ending on the following 30 June.

2.3 For purposes of Section 2.1 of the present Directive regarding Deputy Ministers and Secretaries of State, only those who are effective members of the Council of Ministers, with voting rights, are entitled to have representation expenses.

2.4 The Chief Minister, the Senior Minister, Ministers, Deputy Ministers, Secretaries of State and the Inspector General are entitled to the use of an official car.

## Section 3 Entry into force

3.1 The present Directive shall enter into force upon signature.

3.2 The dates of operation of Sections 1 and 2 of the present Directive are, respectively, the date of the establishment of the Constituent Assembly and the date of the establishment of the Transitional Government.
