ON FEES IN RELATION TO POSTAL SERVICES

For the purposes of establishing a Schedule of user charges in relation to postal services under Directive No. 2000/6,

FEES IN RELATION TO POSTAL SERVICES

Section 1 Application of Fees

Fees shall be levied for services and products provided by UNTAET through the East Timor Postal Service. The services and products for which fees are levied and the amount of these fees are shown in Tables 1-6.

Section 2
Liability for Postal Fees

Postal fees shall payable by the person that engages the East Timor Postal Service to provide the corresponding service or product.

Section 3
Payment Arrangements

3.1 Payments of fees shall be made at the East Timor Postal Service.

3.2 The East Timor Postal Service will act as the agent of the Central Fiscal Authority and shall deposit all fees received thereby into an account administered by the Central Fiscal Authority, except for fees authorized by the Head of the Central Fiscal Authority to be retained by the East Timor Postal Service as part of normal business practice.
