REGULATION NO. 2001/19

ON SUPPLEMENTARY APPROPRIATIONS (No. 5) 2000-2001

The Special Representative of the Secretary-General (hereinafter: Transitional Administrator),

Pursuant to the authority given to him under United Nations Security Council resolution 1272 (1999) of 25 October 1999, as reaffirmed in United Nations Security Council resolution 1338 (2001) of 31 January 2001,

Taking into account United Nations Transitional Administration in East Timor (UNTAET) Regulation No. 1999/1 of 27 November 1999 on the Authority of the Transitional Administration in East Timor, UNTAET Regulation No 2000/1 of 14 January 2000 on the establishment of the Central Fiscal Authority of East Timor, UNTAET Regulation 2000/20 of 1 July 2000 on Budget and Financial Management and UNTAET Regulation 2000/21 of 1 July 2000 on Appropriations (No. 1) 2000-2001 (as amended, including UNTAET Regulation 2000/34 of 16 November 2000 on Appropriations (No. 2) 2000-2001),

After consultations in the National Council,

For the purpose of appropriating money from the Consolidated Fund of East Timor and amending UNTAET Regulation 2000/21 of 1 July 2000 on Appropriations (No. 1) 2000-2001 (as amended),

Promulgates the following:

Section 1 Contingent Supplementary Appropriation 2000-2001 Only

- 1.1 An amount of TWO MILLION THREE HUNDRED AND FORTY THOUSAND FIVE HUNDRED DOLLARS (\$2,340,500) is appropriated to the Central Administration Service for *capital items* as follows:
- (a) \$1,510,000 for the purchase of 1,200 M-16s and Light Machine Guns for the East Timor Defence Force;
- (b) \$337,500 for the purchase of 750 Glock compact pistols for the East Timor Police Service; and

- (c) \$493,000 for the purchase of equipment for the Rapid Response Unit of the East Timor Police Service.
- 1.2 The above appropriation will be provided on the basis of sequestration within the existing 2000-01 budget appropriations.

Section 2 Definitions

Wherever used in the present Regulation, defined terms shall have the meanings set forth in UNTAET Regulation No. 2000/21 of 1 July 2000 on Appropriations (No. 1) 2000-2001 (as amended).

Section 3 Entry into force

The present Regulation shall have entered into force on 1 May 2001.
